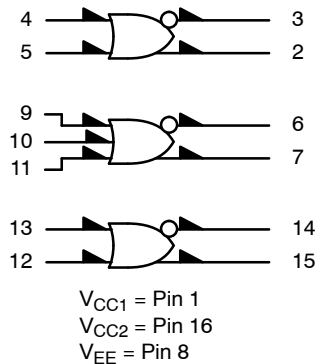
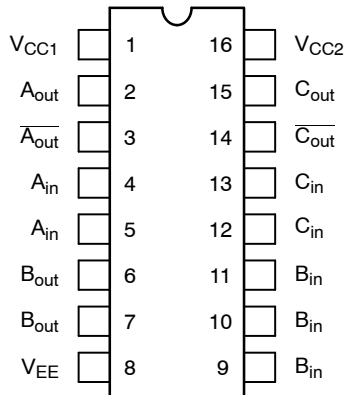


Figure 1. Logic Diagram



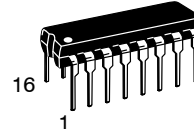

Figure 2. Pin Assignment

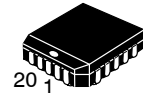

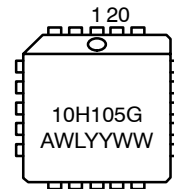
